Visitors Data Analysis Report

1. Overall situation

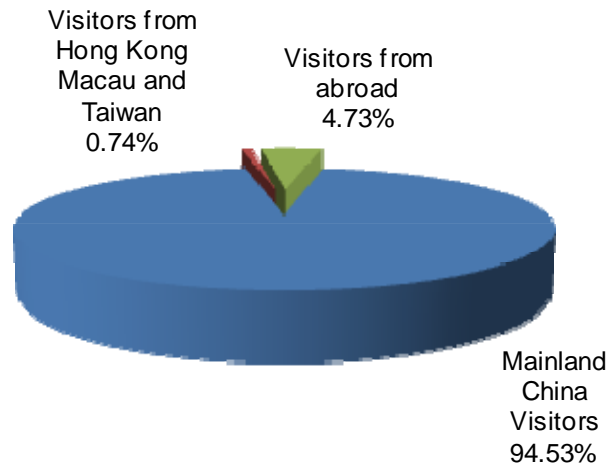
CIDPEX 2017 exhibitors included 672 domestic enterprises (from 31 provinces and autonomous regions) and 58 overseas enterprises (from 17 countries and regions). The total exhibitors number is 730. The area of CIDPEX 2017 is 80000 square meters. Almost 200 sets of equipment were demonstrated on-site.

Visitors came from 31 provinces, cities and autonomous regions in China and 55 overseas countries and regions (including China Hong Kong, China Macau and China Taiwan). The total number of visitors was more than 30,000, including 1374 overseas visitors, which reached a new breakthrough.

CIDPEX conference, which was held during the same period of exhibition, covered the industry hot topics and answered questions in-depth. There were 21 keynote lectures and 5 interactive forums, which attracted nearly 600 audiences. All seats were occupied.

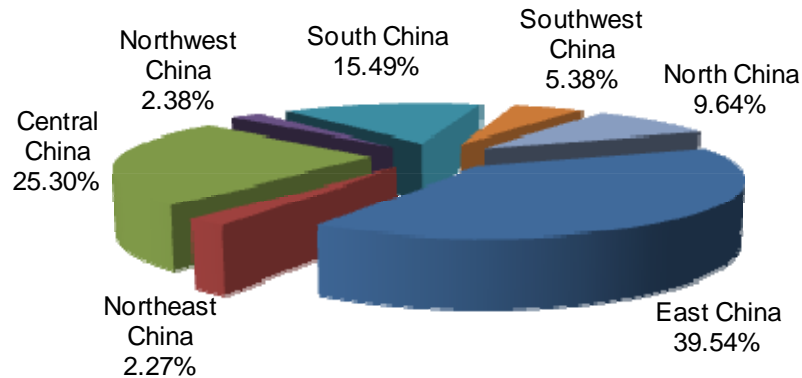
A. The source of the visitors

C. The classified statistic of the Chinese visitors (not include visitors from Hong Kong, Taiwan, Macau)



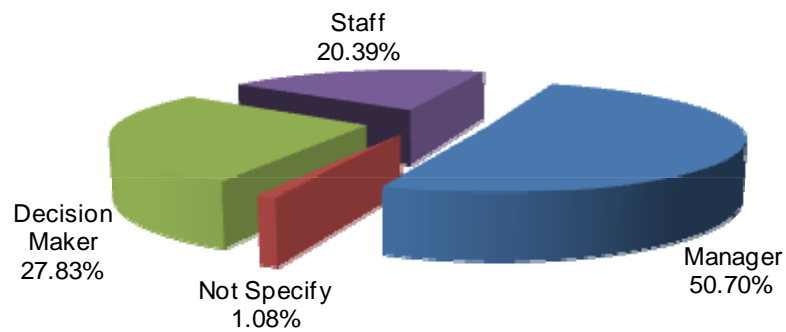

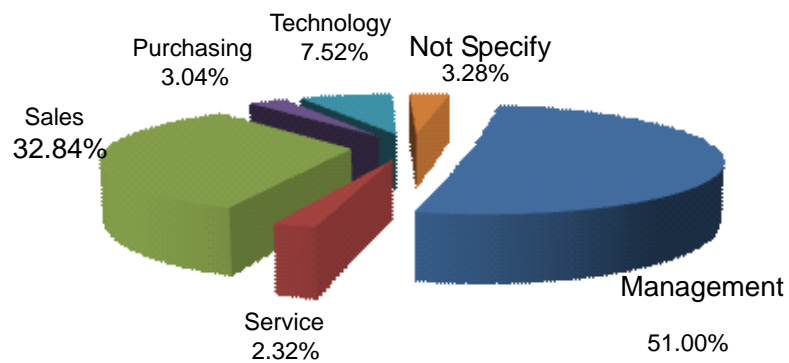

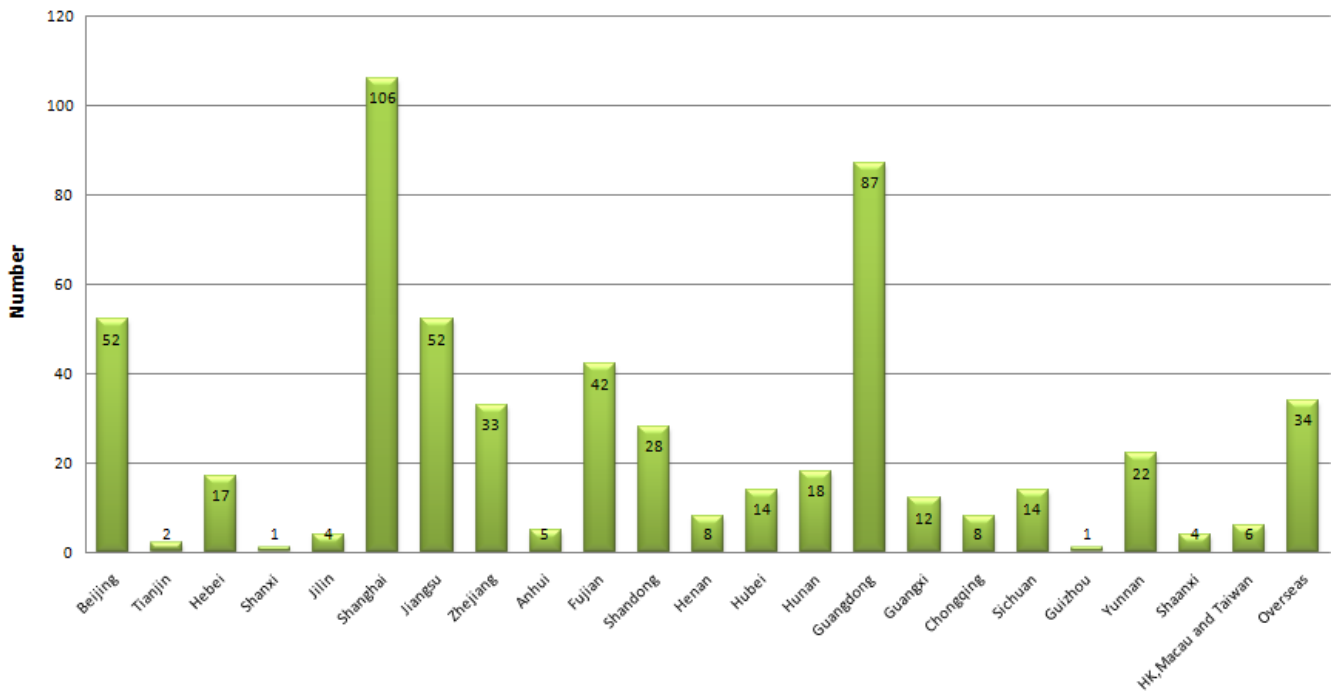
Classified statistic of the visitors' position
